



Moana Music Open Mic Competition

Tātaki Auckland Unlimited Limited (“**Auckland Unlimited**”) and its event partners **Go Media, Six60 and Eccles Entertainment Ltd** welcomes entries to the **Moana Music Open Mic** Competition (the “**Competition**”). By entering this Competition, entrants are deemed to have read, understood and accepted the following terms and conditions.

A. Competition and Entry

1. The Competition will be held on 9 February 2025 at the Hobson Wharf location for the Moana Music Open Mic Competition
2. To enter, entrants must complete the online registration form and include written consent from a parent or guardian if the entrant (or any member of the entrant if the entrant is a band) is under 18 years old on the date of entry.
3. Entries for the Competition must be completed between 15 January 2025 at 00:01 and 28 January 2025 at 17:00. Entries received after this time will not be accepted. All entries are deemed received at the time of receipt by Auckland Unlimited of the completed online entry form and NOT at time of transmission by the entrant. Late, misdirected, illegal, incomplete or illegible entries are invalid. Auckland Unlimited is not responsible for such entries nor for any error, technical malfunction, loss, omission, communications delay or failure.
4. Every entrant warrants that all information submitted is true, current and complete. Auckland Unlimited reserves the right to disqualify any entrant who does not comply with these terms and conditions.
5. Entry is only open to New Zealand residents.
6. Entrants can only enter the Competition once. Only one entry per person will be counted. Bands should submit a single entry.
7. Submission of the entry form does not guarantee a performance slot on 9 February 2025. Auckland Unlimited will select entrants to perform and allocate performance slots at its sole discretion. Those selected to perform as part of the competition will be notified on 29 January 2025 by email. Entrants who have not been selected to perform will be notified on or before 29 January 2025.
8. If a band is selected as the Competition Winner, the band will be awarded a single Prize (as defined below) to be shared among members of the band. Auckland Unlimited will not be responsible for allocating the Prize among members of a band and takes no responsibility for disputes among members of a band in relation to the Competition or the Prize.
9. The Promoter is Auckland Unlimited, Level 7, 167b Victoria Street West, Auckland 1010.

B. Winner selection and Prize

10. The winner of the Competition (**Competition Winner**) will be chosen by one or more judges appointed by Auckland Unlimited and will be announced at the Hobson Wharf location for the Moana Music Open Mic Competition on **9 February 2025** following conclusion of the Competition.
11. The Competition Winner must be present in person and claim the Prize at the Hobson Wharf location for the Moana Music Mic Competition at the time of the announcement.



12. If the Competition Winner is not present and does not claim the Prize at the time of the announcement or if for any reason a Competition Winner's entrant details are incorrect Auckland Unlimited reserves the right to select another winner.
13. If the Competition Winner claims the Prize, the Prize-win and terms and conditions of acceptance will be documented in an email to that Competition Winner.
14. Terms and conditions of acceptance include, but are not limited to:–
 - a. The Competition Winner being available to attend the Six60 Auckland concert on 1 March 2025;
 - b. The Competition Winner being available to attend the backstage tour on 1 March 2025 at a time specified by Eccles Entertainment and Auckland Unlimited in their sole discretion;
 - c. The Competition Winner providing Auckland Unlimited with a New Zealand bank account to receive the Go Media cash prize;
 - d. If the Competition Winner (or any member of the Competition Winner if the entrant is a band) is under 18 years old, a parent or guardian over the age of 18 must attend the backstage tour and Six60 concert with the Competition Winner. Additional tickets will not be supplied outside of the 4 included in the Prize; and
 - e. If a band is selected as the Competition Winner, the band will be awarded a single Prize to be shared among the members of the band.
15. The Prize will only be awarded to the Competition winner once the Competition Winner (or that person's parent/guardian if the Competition Winner is under 18) has accepted the Prize-win terms and conditions in writing.
16. If the Competition Winner declines the Prize, the Prize is immediately forfeited and Auckland Unlimited reserves the right to select another winner.
17. The Prize will be awarded to the holder of the email address from which that entry was submitted via the entry form (or that person's parent/guardian if the Competition Winner is under 18 and the nature of the Prize requires the Competition Winner to be over 18 years of age). Auckland Unlimited takes no responsibility for disputes resulting from entries submitted using an email address belonging to any other person.
18. Auckland Unlimited's and its judges' decisions are final, and no correspondence will be entered into.

C. Prize

19. The Prize consists of
 - a. \$1,000 cash from Go Media, official event partner;
 - b. 4 tickets for Six60's Auckland concert on 1 March; and
 - c. Money can't buy experience backstage tour for four people for the Six60's Auckland concert on 1 March (at a time specified by Eccles Entertainment and Auckland Unlimited in their sole discretion).

(the **Prize**).
20. The Prize is subject to the Competition Winner accepting Auckland Unlimited Prize-win terms and conditions of acceptance as listed in clause 13.
21. The Prize cannot be exchanged for cash, credit or service, is not transferable to any other person and cannot be used in conjunction with any other offer or promotion. No compensation will be payable by Auckland Unlimited or any of its event partners if the Competition Winner is not able (for any reason) to attend Six60's Auckland concert on 1 March and/or the backstage tour.
22. If the Prize or part of the Prize becomes unavailable (for any reason whatsoever, including but not limited to general travel restrictions, earthquakes, storms, landslides, fire, outbreaks of war, acts of terrorism or hostility, strikes, lock-outs, pandemics, protests, and acts of God),



Auckland Unlimited reserves in its sole discretion, the right to either amend the Prize, including providing the Competition Winner with a substitute Prize, either in full or in part, at the same, higher or less value, or to cancel the Prize and/or the Competition in its entirety at any time.

D. Privacy

23. Entry into this Competition is deemed to be acceptance of these terms and conditions.

The Competition Winner consents and agrees to participate and co-operate as required in all promotional activities relating to the Competition and Prize including but not limited to being filmed and photographed during the redemption of the Prize for use on Auckland Unlimited's social media channels and other Auckland Unlimited promotional channels and the Competition Winner agrees that their First and Last Names and image may be used by Auckland Unlimited for promotional purposes including but not limited to, Auckland Unlimited Communications, Email Newsletters, Media and social media including Facebook and Instagram for the purposes of promoting the Competition and Prize and/or Auckland Unlimited.

Auckland Unlimited also reserves the right to refuse to award the Prize to an entrant who is in breach of these terms and conditions, gained an unfair advantage in participating in the Competition or won the Prize by using fraudulent means.
